Minutes of February 17, 2013

The meeting was held at 7:00 p.m. at the home of Karen Grossman. In attendance: Karen Grossman, President; Lally Stowell, Jason Fligg, Erin Fligg, Marshall McCloskey, Sally Hempstead, Bev Williams. Although recent snowstorms have kept us out of the park, we have enjoyed the views from the bike path.

MINUTES from December 2, 2012 annual meeting were reviewed. Karen will add: Goals for 2013, Treasurer's Report, and report of the Beautification Committee before posting on FSPP website. With these additions, the minutes were approved.

TREASURER'S REPORT: Karen thanked Marshall for adding this significant task to his website duties. He noted that \$1095 in donations came in at the end of 2012, but Network for Good notified us in 2013. Marshall has sent acknowledgement letters to these donors for their 2012 gifts.

Checking account - \$13,653

CD \$3,016 (expires in June; Marshall will investigate CDs that may make more interest, although it is difficult for organizations to get a good rate.) 117 people paid dues in 2012. Public Charities report, annual report and tax forms have been submitted for 2012.

BEAUTIFICATION COMMITTEE: Lally reported that the committee met on January 30 at the home of Gail McCormick to suggest Work Days and to divide up tasks for those days. She reported that calling lists are being assembled and that she hopes to have pictures for each planting bed, marking both invasive and other plants to make i.d. easier.

OPEN EYES video - Karen will notify of Work Days.

Sally and Karen will work on LIBRARY DISPLAY for March. Sally recommended that we purchase a new, larger display board that includes a carrying case. Cost - about \$209.

NEWSLETTER: Sally is keeping the archives up to date.
